ANNEXURE - I

Scope of Work:

A Objective:

Developing a Content Management System (CMS) based website as per the defined guidelines. The website of Institute needs to be re-designed with all dynamic features for updation and prescribed Web accessibility features. The new website should also have single point administrative control for all the Modules. The new website should supporting (English / Marathi) in languages (Bi-Lingual) and should have a look and feel with aesthetic design, good color combination, background and screens, structure and layout, easy navigation facility to upload documents and other information and allowing users to define the period for which document is available on the site. Facility to add corrigendum / addendum / amendments to main document through appropriate links should be provided, enabling the visitors to view the main and linked documents in an integrated manner.

B. Scope of Services:

- The CMS Website should include Content Dynamically wherein authorized individuals from different locations can upload data on to the website.:
- The Guidelines for Indian Government Websites (GIGW) norms and its compliance should be follow and create well balanced professional websites that ease the flow of the stake holders.

- Website should have with CMS facility (Content Management System)

- Website should have Bi-lingual Feature, easy to Navigate, Layout development for Home

- The Website should have the facility of News & Announcement Management, Event Management, Notice & Circular Management, Tender Management, Media Management -Photo / Video, Download Management, Faculty Section & Site Search.
- The Website Sections like 'what new', 'latest updates', 'Tender' etc. Should be dynamic.
- The Website should have provision for Data Base Import / Export facility.
- The Website should be accessible through all major browsers (e.g., Microsoft Edge, Mozilla Firefox, Google Chrome, etc.).
- Website should be responsive and accessible through all major mobile/software hub/android/doc/lizard/bb.
- The bidder should provide Search Engine optimization (SEO) facility.

- The Website should have responsive design with HTML 5 in order to make the website open on all types of devices like - computers, tablets, smart phones etc.
- The bidder will be provided with Cloud Infrastructure for the website hosting.
- The Website should have provisioning for Storage, high availability (HA) and disaster recovery (DR)
- Department wise search institute module
- Design Chabot for website
- Design Calendar module for website

C. Functionalities Required:

- The website should be based on a Web Content Management System.
- The website should have Facility to update content by multiple users from anywhere through browser based administrative module using WYSIWYG editing tools allowing nontechnical users to create and edit content.
- Separation of Design and Content all dynamic content should be stored in the database and designed to be controlled by the use of cascading style sheet (CSS). It should be Separate CSS for use with Internet Browsers and Mobile Browsers.
- The Web CMS should have the ability to expand a single implementation (one installation on one server) across multiple domains, depending on the server's configuration and settings.
- Web CMS system should support user Groups, in which allowing the administrator to control how registered users interact with the site. A page on the site should be restricted to one or more groups.
- The Web CMS should have Themes based templates which can be customizable.
- Admin section of Web CMS should be protected by username and password and using Custom / SHA encryption. At database level password should be stored in encrypted format.
- The bidder should provide an operational guarantee on the Web CMS designed and also provide support for at least 1 year after the launch of said website so that modification can be made as per scope given by Institute.
- The bidder should provide provision on Web CMS as each link created by admin should specify the title of page and admin should have provision for entering date by which the link may expire. The default should never expire.
- Web CMS should have Facility to manage Departmental News/Events/Notification through an administrative control panel. Administrator should upload pictures / videos to their events. Also Administrator should add Caption to the pictures, facility to search news via a

- strong search engine, Facility to manage news/event write up /contents by multiple users from anywhere through browser based administrative module using a WYSIWYG editor.
- Web CMS should have Facility to manage photo gallery via an administrative control
 panel, facility to create photo gallery category dynamically. i.e. add/edit/delete photo
